The Competent Authority has been pleased to approve "Inspection Allowance" for Female Assistant Education Officers (AEOs) of School Education Department, Punjab to be payable against inspection of schools upto a maximum amount of Rs.5000/- per month with immediate effect.

The Inspection Allowance will be paid by concerned District Governments out of their own resources. The SOPs of Inspection Allowance are as under:-

heir o	(a) Inspection Allowance @ Rs.5000/-p.m. shall be payable on the basis of at least 50-Inspections of Schools in a month. In case of less than 50-Schools Inspection, it shall be payable on the basis of at least 100/- per school inspection.
	50-Inspections of Schools in School inspection. be claimed @ Rs.100/- per school inspection. be claimed @ Rs.100/- per school inspection shall be entitled to claim the lambda having less than 50-Schools in their jurisdiction shall be entitled to claim the lambda having less than Inspection.
