SUBJECT: THE PUNJAB CIVIL SERVANTS (AMENDMENT) ACT, 1974

I am directed to refer to the subject noted above and to state that the following amendment in the Punjab Civil Servants (Amendment) Act, 1974 (VIII of 1974) has been made vide Notification No.PAP-Legis-2(106)/2011/724 dated 30.07.2012 (copy enclosed):-

"2. Amendment in Section 3 of Act VIII of 1974. - In the Punjab Civil Servants Act 1974 (VIII of 1974), in section 8, after sub-section (6), the following sub-section (7) shall be inserted:-

(7) Notwithstanding anything contained in this section, if a civil servant dies or superannuates after the selection authority recommends his promotion to a higher post and before he assumes the charge of the higher post, the competent authority may approve promotion of such a civil servant with effect from the day immediately before the day of his death or superannuation."

2. Further necessary action may be taken accordingly.
