#### NOTIFICATION

No.SO(CAB-I)2-26/2012. In exercise of the powers conferred under Article 139 of the Constitution of the Islamic Republic of Pakistan read with proviso to rule 49 of the Punjab Government Rules of Business 2011, the Chief Minister is pleased to direct that in the Punjab Government Rules of Business 2011, the following amendments shall be made:

### **AMENDMENTS**

In the said rules, in Second Schedule, under the heading:

- (a) "Health Department", after entry at Sr. No.13, the following entry shall be inserted:
  - "13A. Matters relating to narcotics control and ancillary matters including:
    - (a) legislation regarding sale and use of psychotropic substances or narcotic drugs; and
    - (b) treatment and rehabilitation of drug addicts, in coordination with the Social Welfare and Bait-ul-Mall Department.";
- (b) "Home Department", after entry at Sr. No.34, the following entry shall be inserted:
  - "34A. Matters relating to narcotics control and ancillary matters including:
    - drug enforcement, education, treatment and rehabilitation of drugs addicts in prisons; and
    - (b) mutual cooperation and assistance in the field of enforcement of narcotics laws.";

- "Social Welfare & Bait-ul-Maal Department", after entry at Sr. (c) No.4, the following entry shall be inserted:
  - "4A. Coordination with and grant-in-aid to nongovernmental organizations engaged in the field of narcotics control and rehabilitation of drug addicts."; and
- "Excise & Taxation Department", after entry at Sr. No.3, the (d) following entry shall be inserted:
  - "3A. Matters relating to narcotics control and ancillary matters including:
    - (a) Policy matters related to production, processing, marketing and trafficking of narcotics:
    - (b) management of excise & narcotics police stations; and
    - coordination with Federal Government and (c) ces on all aspects of narcotics."
