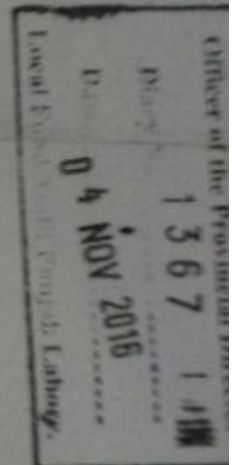
No.FD.SR-1/2-1/95(P). In exercise of the powers conferred under Section 23 of the Punjab Civil Servants Act, 1974, (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab General Provident Fund Rules 1978, the following amendment shall be made:

AMENDMENT

In the Punjab General Provident Fund Rules, 1978, in rule 1.10, for sub-rule (1), the following shall be substituted:

"(1) The subscriber shall pay monthly subscription according to the basic pay scale mentioned in column 1 of the Table at the rate fixed in column 2 thereof:
