SUBJECT:

RE-IMBURSEMENT OF MEDICAL CHARGES.

I am directed to refer to this Department's earlier instructions circulated vide letter No. S.O. (PH) 17-1 / 89, dated 23-08-2005 & 15-11-2006; on the above cited subject.

- 2. I am further directed to convey serious concern regarding non-compliance of the rules / instructions of the Government pertaining to the medical treatment and subsequent re-imbursement of medical expenses pertaining to the employees of the Provincial Government by the attending / treating doctors of Provincial Government Hospitals. The attending doctors usually refer the Provincial Government employees and their dependent family members to the non-Provincial Government / Private Hospitals at their own convenience / employees will without justifying the reasons for referral. This situation is creating administrative and financial implications for the Government. In order to avoid such situation, it has been decided that:
 - No patient shall be referred to the hospitals other than Provincial Government Hospitals without solid justification / reason;
 - All the Referral Slips issued by the attending doctor shall be verified / counter-signed by the Medical Superintendents / Additional Medical Superintendents concerned;
 - iii. Referral Certificate should bear the name of the employee / patient, OPD / Indoor Number, name of hospital where referral is made, reason for referral, and shall have signatures with by-name official stamp of the attending doctor, and counter-signed by the Medical Superintendent / Additional Medical Superintendent concerned with hospital seal;
 - iv. Referral on private letter heads / pads shall not be acceptable in any
 - v. RMC Claims shall not be recommended by the S.M.B. unless routed through the Health Department;

It is further informed that all the Medical Superintendents of Provincial Government Hospitals have also been authorized to refer the entitled Provincial Government employees and their dependent family members to the non-Provincial Government / Private Hospitals in case of emergency justifying reasons and, after You are once again requested to strictly adhere to the above mentioned completing all other codal formalities. instructions in order to facilitate the Government servants.
