No.FD.SR.II-9-107/2012. In exercise of the powers conferred under Section 23 of the Punjab Civil Servants Act. 1974 (Vill of 1974), Covernor of the Punjab is pleased to direct that in the Revised Leave Rules, 1981, the following amendments chall be made:

## AMENDMENTS

In the said Rules, in rule 13:

for sub-rule (1), the following shall be substituted:

"(1) A female civil servant may, for the maximum period of ninety days, be granted maternity leave with full pay outside her leave account, at any time, immediately before or after the birth of a child and she shall not be required to provide fitness certificate for purposes of joining duties after such leave."; and

after sub-rule (7), the following sub-rule (8) shall be inserted:

\*(8) A male civil servent may, for a maximum period of seven days be granted paternity leave on full pay outside his leave account on or immediately before the birth of his child:

Provided that such leave shall be admissible only for two

times during the antire service."
